Prescription Collection

We can arrange to collect your clients' prescriptions from their GPs' surgeries on your behalf. To comply with Care Commission guidelines, we will deliver the forms to your staff to be checked before dispensing.

High Quality Records

When dealing with patients' health and medication, it is vital to maintain clear, legible records. Each of the dispensing methods we use can be supported by computer printed Medication Administration Record sheets (MAR sheets). Laser printing ensures that these records are always clear and easy to read.

The MAR sheets are easily modified, resulting in a flexible system which can be adapted to suit your particular care environment. We will also provide full training and support on every aspect of the record keeping system you choose.

Accredited Training in Medicines in Care Homes*

This comprehensive training package covers all aspects of medicines and the use and administration of medication.

Birdsfoot Lane Pharmacy has supplemented the NPA package with very specific guidance using materials provided by the Regulation of Care and the Royal Pharmaceutical Society of Great Britain.

This enhanced package ensures that staff are fully aware of their responsibilities and how to deal with the medicines they administer.

The training programme takes half a day to deliver but this time can be flexibly arranged to assist home managers with staff planning.

Every staff member who takes this course receives an attendance certificate and there is an optional written assessment which is graded.

We understand the difficulties that many patients face and strive to improve their quality of life by doing what we can to help with their healthcare needs.

Handling Medication in Social Care Settings

This in-depth one-day training programme has recently been produced by the Royal Pharmaceutical Society of Great Britain in collaboration with the Commission for Social Care Inspection and the Association for Real Change.

A structured programme, it includes group workshops and case studies to provide detailed training on all aspects of medication handling.

There is an optional external assessment, marked and graded by an ARC trainer and a certificate awarded at a cost.

Before attempting this course, it is recommended that staff should have already completed the NPA training package outlined overleaf.

Additional Training

Pharmacist Audits

An audit can help you to identify and prevent potential medication issues.

Birdsfoot Lane Pharmacy use a unique checklist to audit every aspect of medicine management within your care home. Experienced pharmacists will carry out the audit and provide you with a copy of the detailed report and associated recommendations.

Regular audits will help to ensure that your home complies with current SCRC guidance on medication.

Section C1 - Medication Storage	YES	NO
Is the storage of external and internal medication separate, secure, supervised, and at an appropriate temperature (not more than 25°C for non-refrigerated items)? <i>(Note – temperature should be recorded on a daily basis)</i>		
Is storage of and self-administered medication correct and safe? <i>(Note – locked drawer or cupboard for each client)</i>		
Is the storage of any medication requiring storage in a fridge correct? <i>(Note – ONLY prescribed medication requiring storage in a fridge)</i>

Pharmaceutical Services for Clients in Care Homes

Case Study

The support and training we give our clients' care homes is as important as our medication dispensing service. This high quality service helps staff to improve clients' clinical care and reduces the wastage of medicines.

In one care home, our pharmacist recognised that dispensed medicines were not always being administered correctly by the care home staff.

The Task

The medical conditions of some care home clients were being compromised because of the incorrect administration of their medication. The care home management asked Birdsfoot Lane Pharmacy to provide training and support to the staff to improve the quality of clinical care experienced by their clients.



The Action

Our Care Services Manager assessed the situation with the care home management team and suggested a tailor-made package of training and audits.

Designed to complement the requirements of the Regulation of Care, the training provided staff with the relevant skills to deal confidently with every stage of medication provision:

- Ordering prescriptions
- Checking prescriptions
- Communication with the pharmacy
- Communication with GP surgeries
- Administration of medication
- Record keeping

Two methods of auditing were suggested - a regular in-house audit using a specifically customised system, supported by external audits carried out by Birdsfoot Lanes' Care Services Manager.

The Solution

By working with and supporting the care home team, Birdsfoot Lane Pharmacy have helped to improve the clinical care of the care home clients and reduce the wastage of prescribed medication.

The progress demonstrated by the internal and external audits was confirmed by Care Commission officers who reported that medication systems within the care home had shown a marked improvement. Staff reported feeling more confident in dealing with medicines and more supported over any issues they had.

To complement these changes, the management of the care home arranged Medication Reviews for each of their clients, many of whom benefited from changes to their medication which enhanced their quality of life. Intensive support like this is unusual but it enabled this care home to make impressively rapid and sustainable improvements.

Pharmaceutical Services for Vulnerable Patients in the Community

Case Study

Many people with progressive illnesses would prefer to stay in the comfort and familiarity of their own homes but find that complicated medicine regimes make this difficult.

One of our pharmacists was approached by a patient in this situation. He had been diagnosed with Parkinson's Disease and the increasing number of different medicines he needed was beginning to cause confusion for him with the result that his wife was spending more time dealing with his medication problems.

The Task

The patient wanted to find a convenient solution which would enable him to continue to self-medicate. A carefully devised system which gave him more independence would give him a better quality of life, improve his health and enable him to stay at home for the foreseeable future.



The Action

The community pharmacist gathered all the relevant information from the patient and arranged an assessment to determine the suitability of a weekly compliance aid. We then enlisted the support of the Practice Pharmacist at the patient's GP surgery. The patient gave Birdsfoot Lane Pharmacy permission to order repeat prescriptions on his behalf and the GP practice agreed to ensure that monthly prescriptions were carefully aligned to coincide. Birdsfoot Lane Pharmacy coordinated the service for repeat prescriptions and arranged a weekly delivery service for the patient's medication in a compliance aid.
